New This Year

In an effort to offer the most robust shopping experience for our guests, we are extending vendor spots to our areas craftsman and vendors at no fee. A \$100 deposit is required which will be returned to any vendor who stays through the entirety of the festival hours and follows all vendor guidelines. A certificate of insurance will still be required. Application acceptance by our events manager is still required.

- 1 Applications received before July 1st will be reviewed beginning after that date. All applications received on or after July 1st will be reviewed and responded to within 2 weeks of submission. Applications CLOSE September 27th.
- 2 Deposit can be made by calling a card to (585)374-1135 or by mailing a check made out to Bristol Mountain to: Attn: April Haynos, Bristol Mountain, 5662 State Route 64, Canandaigua, NY 14424
- 3 Deposit must be received within 2 weeks of acceptance to the Festival.
- 4 All vendors are required to comply with the below Certificate of Insurance guidelines and must submit required insurance documents no later than September 27th, 2024 in order to participate. Failure to provide insurance certificate results in forfeiture of vendor fees and vendor space.
 - All vendors are required to provide \$1 million in general liability insurance per occurrence with no less than \$2 million aggregate.
 - Name and Address of Certificate Holder should be listed as:
 - Troser Management, Inc, dba Ski Bristol Mountain, 5662 State Route 64, Canandaigua, NY 14424
 - List certificate holder as additional insured
 - Coverage must include NYS Workers Compensation if entity has employees.
- 5 Vendor set up is from 8am-10:30am each day. All cars must be removed to the parking lot by 10:30am, no exceptions. Vendors should load out of their cars as quickly as possible and return their cars to the lot to help avoid congestion in the festival area. Vendors with cars on the festival grounds after 10:30am are subject to deposit forfeiture. vendors may not break down before 5pm each day.
- 6 Bristol Mountain is not responsible for any theft, damage, or personal injury to vendor property or staff while on Bristol Mountain Property.
- 7 Vendors may not solicit guests to sign up for any multi-level marketing programs.
- 8 All large trash and cardboard boxes must be removed from the premises at the conclusion of the event. Trash cans are for guest use and not the disposal of large vendor trash items. Failure to leave a tidy space at the conclusion of the festival is subject to forfeiture of deposit.
- 9 Vendors will need to supply their own items to display their wares (tables, chairs, pop up tents, etc.) All displays must fit within the designated space reserved.
